The "product" booths are 25\$ each and will be included in the advertising. Applications are due by January 27th but those that are in earlier are given first preferences in space and advertising.

All participants will be responsible for their own equipment (tables and chairs or other). If you need electricity, outside space or inside space please let us know so we can help plan for that. Anyone selling food must have a temporary permit and food handler's cards. Please check with the County to make sure you are in compliance with the local rules and (Blah, Blah, Blah)
